(i) SHIKHAR BHARGAVA MEMORIAL SAMMAN (DELHI)

- Purpose : To honour for outstanding achievement in any walk of life.
- Award details : Shawl, Citation, Tamra Patra
- Age Qualification : Preferably between 50 years and 65 years
- Attained the following positions : (i) Became Head of any organization with Turn over of Rs. 500 Crore or more.
- (ii) M.D. / C.E.O. / Chairman of any autonomous body or Government organization.
- (iii) Elevated to the position of Secretary at Central Government or Chief Secretary at State level.
- (iv) Chief Justice of High Court or Judge of Supreme Court.
- (v) Outstanding contribution in research and development in any field at National or International level.
- (vi) Any Achievement comparable to above levels.

NOTE: i) Next of kin of the donor family and President, General Secretary of Akhil Bhartiya Bhargava Sabha are not eligible for this Samman.

ii) The honour will be presented at the Inaugural Function of All India Bhargava Sabha 's Annual Adhiveshan.

iii) To publish printed coloured brochure on the introduction and achievements of the honoured person.

(ii) SHIKHAR BHARGAVA MEMORIAL AWARD (DELHI)

- Purpose : To recognize achievements of industrialists / professionals with focus on -
- (i) Corporate Governance
- (ii) Turning a sick unit into profitable one
- (iii) Accelerated growth achievement
- (iv) Any innovation in process or product development.

- Award details : One 10 gm 22 Karat gold coin; Citation; Memento.
Age Eligibility : Preferably 40 years or less
Eligibility : **The person should have excelled in any one or more of the following areas:-**

(Note: The person should preferably be a first generation entrepreneur in his field.)

- (i) Excelled in Governance of a Limited Company or a Private Limited company.
- (ii) Should have succeeded in turning a sick unit incurring losses for three or more years into a nett profit earner for at least three subsequent years.
- (iii) The unit should have achieved growth rate of 25% or more consecutively for at least three years.

(Note: Minimum turnover of the unit should be Rs 5 crore P.A. applicable for above 3 categories)

- (iv) The entrepreneur should have contributed by way of any innovative idea or innovation in product development/ processes development or succeeded in procuring patent/s.

- NOTE: i) Additional weightage to be given to the achievements in the export Promotion.
ii) Next of kin of the donor family and President, General Secretary of Akhil Bhartiya Bhargava Sabha are not eligible for the award.
iii) The Award will be given at the Inaugural Function of All India Bhargava Sabha during Annual Adhiveshan.
iv) To publish printed coloured brochure on the introduction and achievements of the awardee.
